The company is developing its CRWE WORLD (crweworld.com) platform and another digital properties to reach the global online community.

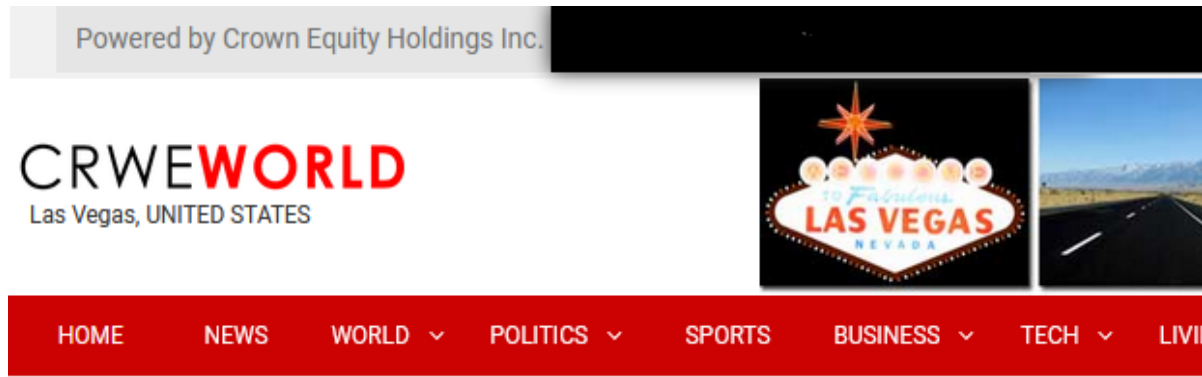


CRWE WORLD (a Crown Equity Holdings, Inc. Company featured on NASDAQ billboard in Times Square. (Year: 2017))

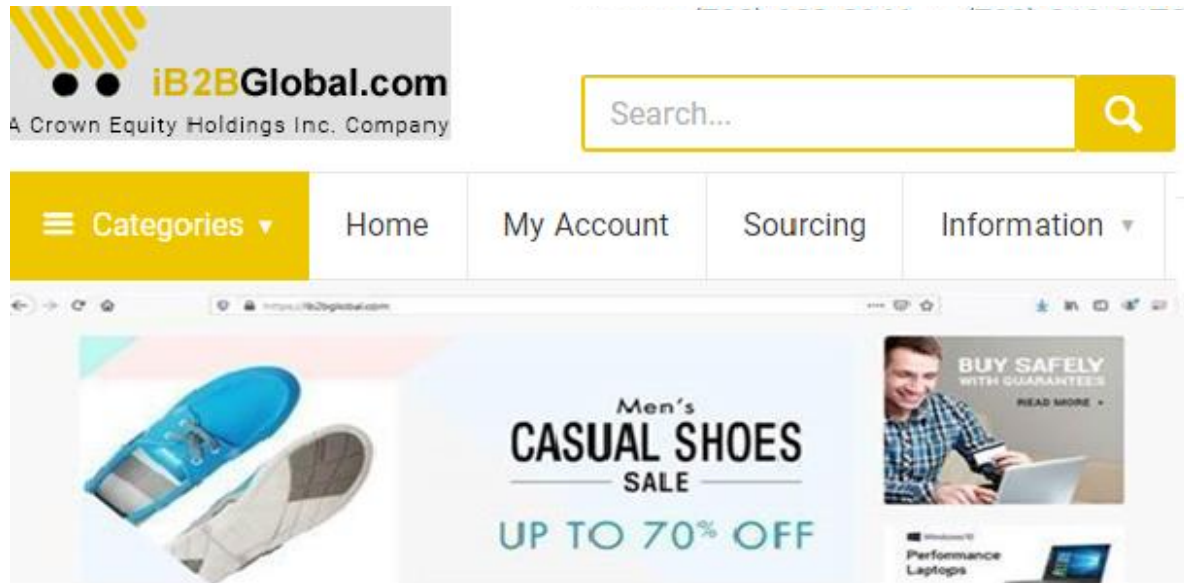

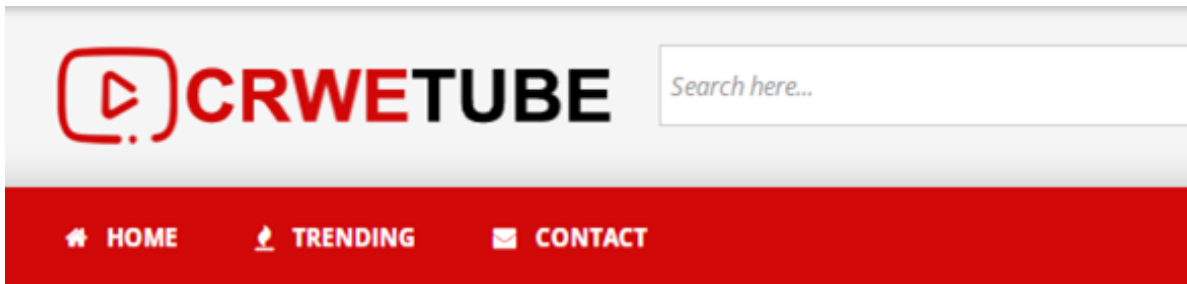
